WHEREAS, these cuts result in the raising of property tax rates in those Host Municipalities exceeding the established inflation rates; and

# RESOLUTION 2012-074 ENDORSING THE CMCMUA PROPOSED SWITCH TO SINGLE STREAM RECYCLING

WHEREAS, the New Jersey Mandatory Source Separation and Recycling Act requires that at least 50% of the Municipal Solid Waste Stream and at least 60% of the Total Solid Waste Stream by recycled; and

WHEREAS, the Cape May County Recycling Plan, as adopted by the County Board of Chosen Freeholders and approved by the N.J. Department of Environmental Protection, sets forth an aggressive source separation and recycling program designed to achieve this State mandate; and

WHEREAS, the Cape May County Municipal Utilities Authority (CMCMUA) and all sixteen Cape May county Municipalities have joined together in a regional cooperative source separation program to increase types and quantity of recyclable materials recovered, maximize market revenues, and minimize costs; and

WHEREAS the Cape May County Intermediate Processing Facility (IPF), which is the cornerstone of this regional program, facilitates the recycling of paper, bottles, and cans (IPF Recyclables) by residents, visitors, businesses, and institutions through the convenience of mixing twenty different items into two streams for municipal collection; and

WHEREAS, the CMCMUA currently operates the IPF to receive, sort, upgrade, and market IPF Recyclables collected by all municipalities in Cape May County; and

WHEREAS, municipal collection of the IPF has used two separate containers (known as dual stream) to accommodate the operation of the IPF since 1990; and

WHEREAS, the CMCMUA has solicited the opinion and commitment of Cape May county's Municipalities to change their municipal source separation and recycling program and the County IPF to single stream, whereby all IPF recyclables would be placed in a single container for municipal collection; and

WHEREAS, the switch from dual stream to single stream recycling in other municipalities in New Jersey has been shown to increase the quantity of materials that are recycled; and

WHEREAS, increased recycling conserves additional natural resources, conserves energy; reduces pollution; and extends the life of Cape May County's only operating landfill; and

WHEREAS, implementation of single stream recycling will reduce municipal expenditures by collection of recyclables from a single recycling container instead of the current dual stream system; and

WHEREAS, the Shared Services Agreement for solid Waste and Recycling executed between the Borough of West Wildwood and the CMCMUA requires that all net revenue from the operation of the IPF be rebated to the County's Municipalities in proportion to the total tons recycled by each Municipalitie; and

WHEREAS, single stream recycling presents the potential for each of the County's Municipalities to receive additional revenue in rebates from the CMCMUA and from the State of New Jersey under the Recycling Tonnage Grant Program, as a result of any increased recycling tonnage; and

WHEREAS, any increased recycling tonnage realized by the switch to single stream recycling will save the municipality landfill disposal cost through avoidance of the tipping for every additional ton, or portion thereof, recycled; and

WHEREAS, single stream collection and processing makes recycling easier for the residents, visitors, and businesses of the Borough of West Wildwood.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Commissioners of the Borough of West Wildwood, Cape May County, New Jersey, that the Borough of West Wildwood hereby endorses the concept of switching from dual stream to single stream recycling for both the Municipal Recycling Program and the County-wide Recycling Program, including the IPF; and

As advertised, Proposals for Engineering Services to the Borough were opened August 30, 2012 at 11:00 A.M. at Borough hall. Proposals were viewed and considered by Proposal Review committee, comprised of Commissioner Golden, Deputy Clerk Ohala and Solicitor Bittner. An evaluation was done in public, with a recommendation made by the Committee; memorialized in this Report, as per N.J.S.A. 40A:11-4.5(d).

#### Vendor name and summary of proposal.

Fralinger Engineering, PA (Fralinger) submitted a proposal which complies with the request for proposals and qualifications delineated in the Scope of Work. Fralinger identifies Carl R. Gaskill, PE, PLS, PP, CME as the engineer who will be responsive to the Borough with all engineers having an hourly rate of \$135.00. Fralinger will also charge for office typist services at \$45.00 per hour, as well as for copies and all postage. Fralinger is willing to negotiate lump a sum fee for capital improvement projects. With regard to current municipal work in Cape May County, Fralinger identifies itself as the City Surveyor for Ocean City and the Special Project Engineer for Dennis Township. Franlinger's office is in Bridgeton.

Mott Associates, LLC (Mott) submitted a proposal which complies with the request for proposals and qualifications delineated in the Scope of Work. Mott does not identify which engineer would be the primary engineer for the municipality. An engineer from Mott will charge an hourly rate of \$95.00 and Mott will not charge to attend Borough Commission meetings. Mott is willing to negotiate a lump sum fee for capital improvement projects. Mott's offer is for a term of one year. Mott identified Ocean City and Cape May as Municipalities in the County for which is has done work. Mott's office is in Egg Harbor Township.

Remington & Vernick Engineers (R&V) submitted a proposal which complies with the request for proposals and qualifications delineated in the Scope of Work. R&V identifies Mark DeBlasio, PE, PP, CME as the engineer who will be responsive to the Borough and whose hourly rate is \$135.00. Remington and Vernick will not charge for calls to them from the Borough, nor for on-site meetings. R&V will not charge for attending Borough meetings. R&V is willing to negotiate lump sum fees for capital improvement projects. R&V identified a number of municipalities in Cape May County where they have served as municipal engineers and have provided engineering expertise, including Wildwood, North Wildwood, Wildwood Crest, West Wildwood, North Wildwood and Cape May. R&V's office is in Wildwood.

Van note – Harvey Associates PC (Van note) submitted a proposal which complies with the request for proposals and qualifications delineated in the Scope of Work. Van note did not specify which engineer would principally serve the Borough. However, in the past it was Mr. Petrella who was the principal contact and attended Borough Meetings. Mr. Petralla's fee is listed as \$155.00 per hour. Van note is willing to negotiate a "not to exceed fee" for particular capital projects. Van note identified a number of municipalities in Cape May County where they have served as municipal or special project engineers,

including Wildwood, North Wildwood, Wildwood Crest and Cape May. Van note's office is in Cape May Court House.

#### Rank vendors according to evaluation criteria.

All proposals appeared to be from qualified engineering firms with appropriate licenses and expertise to offer municipal engineering services. All proposals appeared to be responsive to the advertised Scope of Work. The differences in the proposals were in fee for services, experience in Cape May County and the communication practices of the firm and/or ease of access to professionals. The committee ranked vendors, in order of least preferred, as follows for the reasons given:

Mott is the least preferred vendor. The hourly rate of \$95.00 was out of line with what is understood as usual and customary in the industry, which causes concern that time may be inflated for the vendor to receive fair compensation. In line with that concern, it appears Mott will charge for service other vendors will not, such as calls to and meetings with the engineer. Mott's proposal was for only one. Year. Therefore, what may or may not be an advantageous fee structure, was only offered for one year, giving cause for concern it would increase for future years of service. Therefore, the identified fee, although apparently low, was not considered an attractive part of this proposal. In looking at Mott's experience in Cape May County, it appeared low compared to other proposals. Borough engineering needs usually intersect with County engineering issues; given a county road runs through the Borough, as well as other factors. Therefore, the relative inexperience in the County was considered a draw-back to this proposal.

Van note was considered the next least preferred. Van note's rate was higher than the other proposals, at \$155.00 per hour; also charging for attendance at Borough meetings. A member of the Proposal Review committee expressed concern at the communication practices of Van note in the past in that there was inadequate communication with members of the governing body; and none since this administration has been in office.

Franlinger's proposal was preferred to that of Mott and Van note. Fralinger's fee was comparable to R&V's, at \$135.00 per hour. However, Fralinger will also charge for other items not listed as additional charges in R&V's proposal, such as time for office typists and all postage. It was the comparison of Franlinger's experience in Cape May County with that of R&V which puts Franlinger's proposal clearly behind R&V's in terms of preference. Fralinger does not appear to have significant experience in Cape May County.

R&V's proposal was the most preferred. The fee seemed fair; especially given no additional charges will be assessed for clerical services, attending Borough meetings, calls from Borough personnel or on-site meetings. Moreover, R&V has significant experience in working with the County and with neighboring municipalities which share similar coastal engineering issues. Open access to and communication with R&V engineers, which is encouraged by the fee structure and has been evidenced by Mr. DeBlasio, the engineer identified as serving the Borough, gives the Review Committee confidence R&V will be available and responsive to all Borough engineering needs. The fact R&V has a local office in Wildwood and will not charge for on-site visits bolsters the reasons for ranking their proposal first.

#### Vendor recommendation:

For the foregoing reasons, the Proposal Review Committee recommends R&V as the municipal engineer, for a three year term. The recommendation is unanimous.
