## A RESOLUTION AMENDING THE POLICIES AND PROCEDURES MANUAL

WHEREAS, in accordance with Resolution 2012-007, the Borough of West Wildwood adopted a Policies and Procedures Manual (Manual) effective date January 01, 2012; and

WHEREAS, it is deemed to be in the best interest of the Borough to amend certain policies and procedures;

**NOW, THEREFORE, BE IT RESOLVED**, by the Board of Commissioners of the Borough of West Wildwood, Cape May County, New Jersey that the policies and procedures of the Borough are hereby amended, as described below, with amendments being made to the Manual.

1. Page 15, fourth full paragraph, shall be amended as follows:

#### Breaks:

All Employees are entitled to [one half hour (30 minutes)] <u>a one hour</u> lunch that is to be arranged by the supervisor so that offices continue to function. All employees are entitled to fifteen (15) minute break in the morning and in the afternoon, subject to administrative approval for times. Administrative personnel must arrange breaks so that office continues to function.

2. Page 18, list of paid holidays, shall be supplemented as follows:

Half Day New Year's Eve Primary Election Day General Election Day Day After Thanksgiving Christmas Eve Day Special Election Day

3. Page 19, table of vacation days, shall be deleted in its entirety and replaced with the following:

a.	1 through 10 years of service:	14 vacation days
b.	11 through 15 years of service:	21 vacation days
C.	16 through 20 years of service:	28 vacation days
d.	21 through 25 years of service:	30 vacation days
e.	26 plus years of service:	35 vacation days

4. Page 19, first full paragraph, shall be amended as follows:

Newly hired full time employees will earn one vacation day per month for the first twelve months of hire. Vacation request must be submitted at least seventy-two (72) hours in advance of anticipated date requested except in cases of emergency. Vacation approvals are at the discretion of the supervisor and shall not be unreasonably denied. [Up to 5 days vacation time can only be carried into the following calendar year.]

Unused vacation time can only be carried into the following year. Up to 10 days of unused vacation time may be cashed out, employee must notify the Borough in writing by December 15<sup>th</sup> of their intent to cash out vacation days, as long as funds are available in the budget. The Borough will pay out no later than February 15<sup>th</sup> of the following year.

5. Section Three of the Manual, at the end, which, at present, prior to amendments made herein, is at page 21, shall be supplemented as follows:

Each employee is entitled to three (3) personal days without giving a reason therefore. A personal day is to be used for the purpose of attending to personal obligations which cannot be addressed during normal working hours. Personal days are to be allotted on January 1 of each year. Under normal circumstances, employees are required to give 48 hour notice to their supervisor. Approval of such days will not be unreasonably denied. Personal days may not be carried over into the succeeding year. No personal day may be used to extend a scheduled vacation or holiday either at the beginning or end thereof unless the employee has obtained prior approval from his/her supervisor.

**NOW, THEREFORE BE IT RESOLVED,** the Board of Commissioners of the Borough of West Wildwood, County of Cape May, New Jersey, hereby approves and adopts the Policies and Procedures Manual as revised and amended herein, effective retroactively to July 13, 2012, a copy of which is on file with the Municipal Clerk; and

**BE IT FURTHER RESOLVED**, that the conditions and applicability of these amendments shall extend to the same resolved conditions and applicability as established in Resolution 2012-007, as set forth in their entirety herein.

**BE IT FURTHER RESOLVED,** the Acting Borough Clerk is directed to provide a copy of this resolution to all employees, obtaining the executed confirmation of receipt of same, and to do so forthwith, and append a copy of this Resolution to the inside cover of all Manuals in the possession of the Borough.
