ORDINANCE NO. 629 (2024)

**ORDINANCE ADDING CHAPTER 520-11 OF THE CODE OF THE BOROUGH OF
WEST WILDWOOD ENTITLED “VEHICLE TRAFFIC”**

WHEREAS, the Board of Commissioners of the Borough of West Wildwood have determined that certain amendments to the Code of the Borough of West Wildwood are required.

NOW, THEREFORE, BE IT ORDAINED by the Board of Commissioners of West Wildwood that Chapter 520-11 (“Vehicle Traffic”) of the Code of the Borough of West Wildwood is hereby added in its entirety as follows:

SECTION 1. The allegations of the preamble are incorporated herein as if set forth in full.

SECTION 2. VEHICLE TRAFFIC.

The following streets or portions of streets as additional areas where parking will not be permitted:

SECTION 3. Any other Ordinances inconsistent with this Ordinance, to the extent of such inconsistencies only, shall be and the same hereby are, repealed.

SECTION 4. This Ordinance shall take effect 10 days after its final passage and publication as required by law.


