ORDINANCE NO. 630

ORDINANCE REGULATING UNHITCHED TRAILERS

WHEREAS, Board of Commissioners of West Wildwood have determined that certain amendments to the Code of the Borough of West Wildwood are required.

NOW, THEREFORE, BE IT ORDAINED by the Board of Commissioners of the Borough of West Wildwood that Article III Chapter 159-11("Unhitched Trailers") of the Code of the Borough of West Wildwood is hereby added in its entirety as follows:

SECTION 1. The allegations of the preamble are incorporated herein as if set forth in full.

SECTION 2. 159-11:

"PROHIBITION OF UNHITCHED BOATS AND TRAILERS IN
THE STREETS RIGHT-OF-WAYS, AND SIDEWALKS OF THE
BOROUGH OF WEST WILDWOOD

- A. It shall not be lawful to park or leave standing any unhitched boat, trailer or other towed conveyance, used in transporting of boats, in or upon any street right-of-way or sidewalk in the Borough of West Wildwood whether or not said boat, trailer or towed conveyance is licensed."

- B. Notwithstanding the provisions set forth above, unhitched trailers and boats shall be permitted in the streets from April 10TH TO May 10TH "

SECTION 3. Any other Ordinances inconsistent with this Ordinance, to the extent of such inconsistencies only, shall be and the same hereby are, repealed.

SECTION 4. Should any section, paragraph, sentence, clause or phrase of this Ordinance be declared unconstitutional or invalid for any reason, the remaining portions of this Ordinance shall not be affected thereby and shall remain in full force and effect and to this end, the provisions of this Ordinance are hereby declared to be severable.

SECTION 5. This Ordinance shall take effect immediately upon final passage and publication according to law.


