WHEREAS, the parties wish to make an amendment to the Agreement to establish a new salary guide.

NOW, THEREFORE BE IT RESOLVED, by the Board of Commissioners of the Borough of West Wildwood, County of Cape May, New Jersey, that Article XVII is amended as follows:

- 1. The amendment to the Agreement between the Borough of West Wildwood and the Cape May County Lodge No. 7, Fraternal Order of Police, dated January 1, 2021, through December 31, 2025, is hereby approved.
- 2. The New Salary Guide, as outlined below, shall become effective in the first full payroll period which begins after formal approval by the governing body; and the yearly salary will be prorated for the remainder of the months prior to the individual obtaining the next step increase on the hiring anniversary date.
